Maheen Ahmed | Deputy Director of Community Awareness, Response, and Engagement (CARE), California State Attorney General Rob Bonta. CARE is an office she crafted and established in 2021 in order to engage with historically marginalized and underrepresented communities across California to increase transparency and address barriers to accessing justice. Maheen joined the California Department of Justice after serving as then-Assemblymember Rob Bonta's Legislative Director, where she shaped and oversaw progressive budget and policy priorities. Maheen became the first Muslim legislative director in the history of the California state legislature in 2019, and had joined the California State Legislature in 2016 as a Jesse M. Unruh Fellow. Maheen strives to devote her life to working towards social equity through systemic changes and amplifying and empowering marginalized peoples. She has received her Bachelor's degree from the University of California, Davis in Community and Regional Development, and received her Master's degree in Public Administration from the USC Sol Price School of Public Policy.



**Celia Bote** | Managing Director, Targeted Victory. Celia is a senior member of Targeted Victory's Client Strategy team where her focus is to help drive our digital persuasion and digital advertising efforts. This included a six-part unscripted video series that Farrah produced, shot, and edited, to promote AAPI engagement in the 2020 Census executive produced by Visual Communications in collaboration with APIELA and EPIC. Beyond nonprofit work, Farrah is a cinematographer who has worked on projects ranging from award-winning short films and bite-sized series to music videos and experimental documentation. Farrah is serving as Producer on a feature documentary about the longest-running Asian American free arts series, Tuesday Night Cafe.

Mai has developed and implemented winning campaigns for local school bonds, ballot measures, and progressive candidates. Mai specializes in uplifting authentic narratives from candidates and supporting organizations to elevate the impact of their advocacy efforts. Before being elected to the Sacramento City Council in 2020, Mai co-founded Hmong Innovating Politics (HIP), an organization whose mission is to strengthen the power of disenfranchised communities through innovative civic engagement and strategic grassroots mobilization.
